In December 2012, the Legal Profession Qualifying Board (LPQB) of Malaysia declared that graduates with a Bachelor of Law (Hons.) awarded by Multimedia University from 2009/2010 onwards are exempted from the Certificate in Legal Practice (CLP) examination. As a result, MMU law graduates fall within the definition of a 'qualified person' under the Legal Profession Act 1976 (Act 166), and may be admitted as advocates and solicitors in West Malaysia upon completion of the prescribed period of pupillage. Similarly, MMU law graduates are also qualified to be admitted to the Bar in Sabah (State Gazette G.N.S. 7/2010) and Sarawak (Swk. L.N. 151).

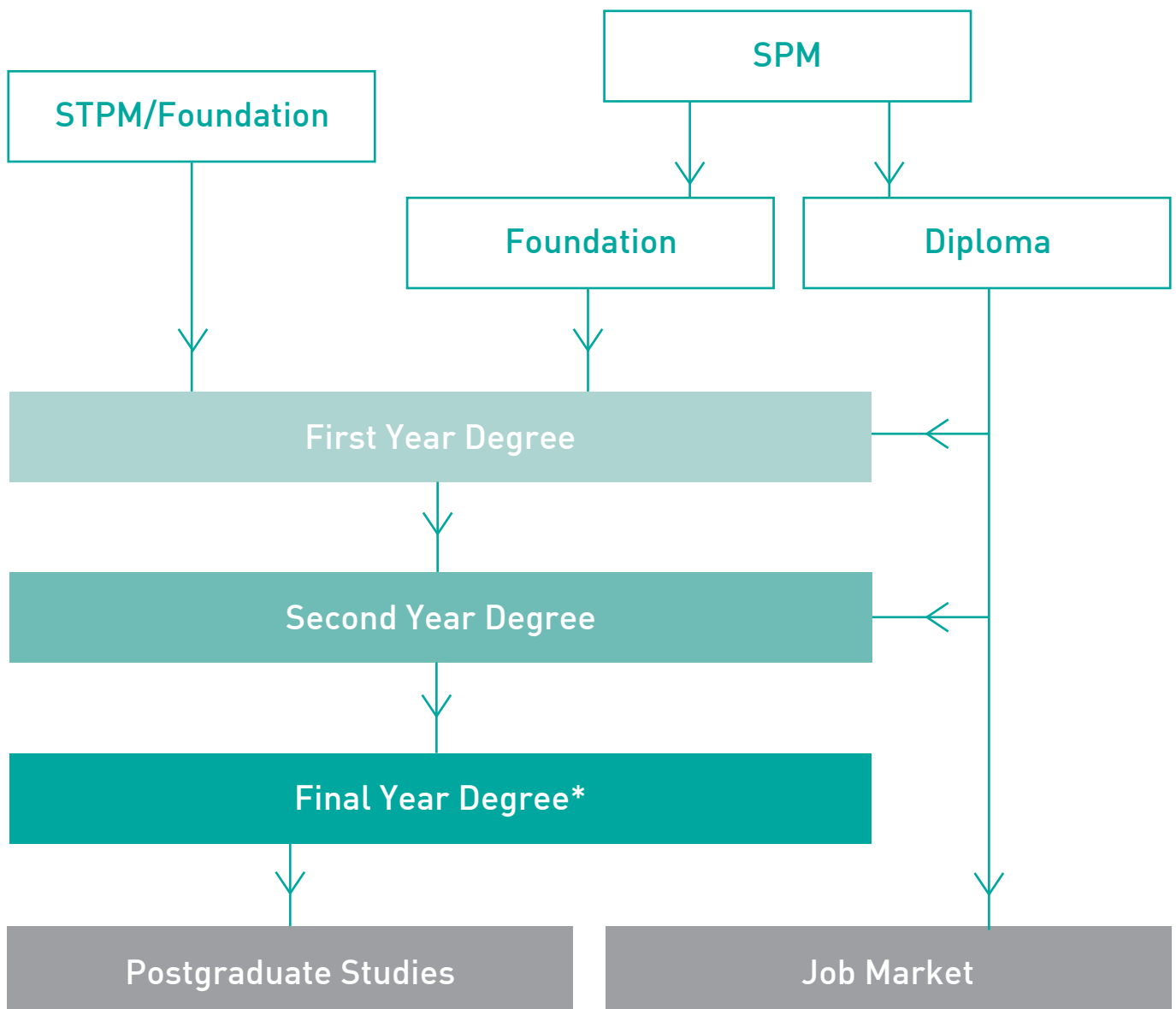

This one-year foundation programme serves as an entry point for the Bachelor programme, which enhances knowledge and skills to pursue the undergraduate degree programme in Law. MINIMUM ENTRY REQUIREMENTS

Foundation In Law

- Pass SPM / O-level or its equivalent with minimum of grade C in at least five (5) subjects, inclusive Bahasa Malaysia and at least a B+ in English; OR
- Other equivalent qualification recognised by the Malaysian Government.

Bachelor of Law (Hons.)

- Pass Foundation / Matriculation from a recognised institution, and pass SPM with 5 credits, inclusive Bahasa Malaysia; OR
- Pass STPM / A level or its equivalent with 3 Principals and pass SPM with 5 credits, inclusive Bahasa Malaysia; OR
- Pass Diploma in related field from a recognised institution and pass SPM with 5 credits, inclusive Bahasa Malaysia.
